Greetings to you,

First off, let me say a special thank you to your team of personnel...your assistance is well appreciated.

I am writing to tell you of my wonderful experiences since my combo talisman arrived. I collected it and immediately things began to change on my job.

#### ON THE JOB:

My supervisor is not as hard on me like before and is more open to suggestions from me regarding work. The other supervisor whom I was assigned to while my own supervisor was on sick leave has hardly any liaison with me and his assistant has not harassed me at all. She used to throw profanity and sly comments my way but this has all stopped. I was intimidated to report her to the HR Dept but since receiving my talisman, I have gathered the courage and have gotten a reply from them almost immediately about their course of action against her.

#### INTERNAL VACANCY:

Since during my intolerable marriage to my now divorced husband, he promised me a car but this went up in smoke. I wore my talisman for the first time that I was going to the bank for my loan. I was successful in this application and I have purchased my own vehicle direct from Japan, which is due to arrive on the 1st week of June!

#### DIVORCE FINALIZED:

I was hanging by a thread with waiting for my decree absolute from the Family Court; the holdup was my ex-husband paying off the balance of the lawyer's fee. Sad to say that he thought he had the 1-up on me but it's a good thing when you live and do good with people. My cousin works for a lawyer and she had to transact business at the same court. When I told her of my dilemma she offered to get it for me for a small fee that is charged by the court. #### USA VISA:

The only vital information I needed to complete my visa application was the date of divorce as stated on my decree absolute. As soon as I got that document, I completed the application, paid the visa fee and scheduled an appointment with the consulate in Port of Spain. My appointment was carded for 6th May at 10am. I got there

and was nervous to the core. When my name was called to go to one of the booths to be interviewed, the officer questioned me in various ways. He asked me about my job, my home life, my kids, what my parents do for a living, where would I stay, how would I pay, who would see my kids if I plan to go alone, etc. After he asked these, he looked a bit skeptical and I thought that I was going to be denied my visa entry into the USA; I was wrong! He granted me a 10-yr US visa and told me that if he wasn't convinced that my info was legit, he would not have given me the approval.

I wrote the above things to reflect on what transpired with me over approximately a 2-mth period after getting my combo talisman. I thank you very much swami bodhi for recommending this combo. I have shared your insight with a co-worker who has similar issues with the same assistant who tried to trouble me and I hope she decides soon to fix her life and get rid of the struggles and negativity.
