### **My testimonial**

It took me all that time to reveal that I was very hesitant about the whole episode of court proceedings and not be able to disclose to anyone that I was facing serious charges under the BYLAW. Being the owner of a rental Property in British Columbia; where tenants growing Marijuana in the house. City BYLAW requires the landlords to be aware and inspect from time to time the activities of the tenants.

As a landlord; unfortunately I neglected that responsibility over the period of a year and I was reluctant to check up on tenants because they had vicious dogs on the property and they were rude. When my tenants were charged for growing Marijuana, the authorities also started criminal proceedings against me where I was facing heavy fines and possibly a jail term in year 2008.

I came across the name of Swami Krsna from Dallas, Texas and I was told that he could help me to solve my problems. I struggled within myself for a while before I had the courage to contact him, but I could not discuss my problems over the phone with him and I never did.

I called and requested him to visit my home in British Columbia, Canada (September/October 2007), I was not sure if this would really work, but I went along because I was desperate and I was somewhat happy when he accepted my request to come.

When he came I really did not tell him much about the situation and asked him to conduct a Shanti Havan for me and my family, Swami Krsna did a grand Havan to Devi Baglamukhi. After the Havan was completed, we were just sitting in my home and discussing about the future, Swami Krsna assured me that the Havan to Devi Baglamukhi is so powerful that "even if someone was facing criminal charges they will be suddenly dropped". I didn't even mention anything about the court proceedings and I wasn't sure what and how to respond to his suggestions. I still kept quiet and said nothing.

Swami Krsna went back to Dallas and a month later (around first week of December 2007) my lawyer and I appeared in court to attend my court proceedings, but I was astounded when I did not see my name on the court list, I just couldn't believe my eyes, I ran around to check my name on all the court lists and I also went to the Police station. **Yes!** It was confirmed to me that charges were never forwarded to the court. After coming out of the Police Station, I just dropped to the ground. I was so relieved that I felt like I was in heaven. This was definitely a Miracle created by God's Power through the Havan Ceremony to Devi Baglamukhi conducted by Swami Krsna. Thank You God!!! And thank you SK.

The second time experience came through when my Son, a healthy young man developed a mind twisting pain in his head from nowhere, he started to have several sharp shooting daily attacks that lasted 5 to 20 minutes at a time. It went on for several weeks before I contacted Swami Krsna and requested him to help my Son. Once again he told me that a Havan done to Lord Shiva in the form of Maha Mritunjaye will relieve his problem and no doctor will be able to diagnose or do anything for him. My Son and I had consulted several specialists and went through numerous tests with inconclusive results. No doctor was able to diagnose the reason for his shooting pains.

Swami Krsna accepted my invitation to visit my son in Toronto, Ontario (December 2008) and perform a Havan Ceremony for his well being. Swami Krsna conducted the Maha-Mritunjaya Havan at my son's home and Swami Krsna told my son that by the end of 30 days the pain will disappear on its own and he will be perfectly cleared from his discomfort, although I was very optimistic, but my son and his wife were not so optimistic about this approach because they have not had miraculous experience in their lives and they were putting their education before their faith and they were being almost negative. After the Havan Ceremony my son was getting regular attacks for the next 28 days and then frequency of attacks had changed to lesser shooting pains.

It certainly did help my son tremendously and he was not living with pain so-much as before, but the attacks were still happening and I told my son to have faith; what I realized was that when Swami Krsna was about to perform Havan Ceremony at my son's home he asked me to have my son and his wife facing the easterly direction during the ceremony. This is where I made the mistake having them facing in a different direction because I didn't know the right direction, I just didn't realize the importance of Disha (direction). This error was not discovered until after the thirty days were over and my son was still having fewer attacks. To a non believer, this might be a coincident, but not in my mind. I have had a life changing experience earlier and no one was going to have me think differently.

I have had a very strong belief and wanting my son's pain to disappear. So one day, I visualized that I am standing in front of a Devi Baglamukhi and asked her forgiveness for the mistake I made during the Havan ceremony. At this time, almost six weeks had passed from the time of Havan ceremony and my Son was losing his faith. I was so sure of my belief in Swami Krsna so I never gave-up, but I stopped asking my son about his condition because he was being bothered by.

Finally at the end of 60 days, my son informed me that he was no longer experiencing the pain and he was relieved from the discomfort. Yes! He was happy, but I was so happy that I did not sleep for days in excitement and I thanked Swami Krsna and Devi Baglamukhi for Her blessings. Yes it took one extra month, but it worked and my son is relieved.

I believe Swami Krsna and his services will bring a complete recovery in anyone's life even into the lives of non-believers.
